

1 [Extending Time for Negotiations]

2 **Motion extending time for negotiations pursuant to Charter Section 11.100**

3 WHEREAS, The City has been meeting and conferring with labor organizations over
4 successor collective bargaining agreements in accordance with Charter section A8.409; and

5 WHEREAS, In order to be included in the budget to take effect July 1, 2003 an
6 agreement or arbitration award must be approved and implemented by ordinance within
7 timelines set forth in Charter Section A8.409-4, as may be extended by Charter Section
8 11.100; and

9 WHEREAS, The Board of Supervisors previously clarified such deadlines in Resolution
10 No. 91-97; and

11 WHEREAS, Under Charter Section A8.409-4 the Human Resources Director has
12 requested that the Board of Supervisors take action pursuant to Charter Section 11.100 to
13 extend by thirty days the date for final adoption of ordinances approving and implementing
14 successor collective bargaining agreements; now therefore, be it

15 MOVED, That the date for final adoption of ordinances approving and implementing
16 successor collective bargaining agreements to be effective July 1, 2003 is hereby extended by
17 thirty days. For unions and unrepresented employees in negotiations for which impasse has
18 not been declared, the date for final adoption of ordinances approving and implementing
19 successor collective bargaining agreements to be effective July 1, 2003 is May 1, 2003. Such
20 proposed collective bargaining agreements must be submitted to the Clerk of the Board on or
21 about April 1, 2003 in a form that will allow for complete review and costing in time for final
22 adoption by May 1, 2003; and be it

23 FURTHER MOVED, That Arbitration panel awards issued pursuant to Charter Section
24 A8.409-4 shall be submitted to the Clerk of the Board on or about May 27th, 2003 in a form
25 that will allow for complete review and costing in time for final adoption by June 30, 2003.
