3 **Ordinance authorizing settlement of the lawsuit and claims filed by Chime Financial,**
4 **Inc. against the City and County of San Francisco for \$2,949,467; the lawsuit was filed**
5 **on February 28, 2024, in San Francisco Superior Court, Case No. CGC-24-612727;**
6 **entitled Chime Financial, Inc. v. City and County of San Francisco; the claims were filed**
7 **on May 29, 2024, and February 4, 2025; the lawsuit and claims involve claims for refund**
8 **of gross receipts, homelessness gross receipts, and commercial rents taxes, and**
9 **business registration fees; other material terms of the settlement relate to Chime**
10 **Financial, Inc.'s filing position with respect to City taxes.**

11
12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
14 authorizes the City Attorney to settle the action entitled Chime Financial, Inc. v. City and
15 County of San Francisco, San Francisco Superior Court, Case No. CGC-24-619318, and
16 claims, by the payment of \$2,949,467 and the parties' agreement on Chime Financial, Inc.'s
17 filing position with respect to City taxes. The lawsuit and claims involve claims for refund of
18 gross receipts, homelessness gross receipts, and commercial rents taxes, and business
19 registration fees.

21 Section 2. The above-named action was filed in San Francisco Superior Court on
22 February 28, 2024, and the following parties were named in the lawsuit: Plaintiff Chime
23 Financial, Inc. and defendant City and County of San Francisco. The claims were filed on
24 May 29, 2024 and February 4, 2025.
