CREATING UNDERGROUND DISTRICT NO. 353 IN THE MID-LAKE STREET AREA.

Note:

This entire section is new.

Be it ordained by the people of the City and County of San Francisco:

Section 1. In accordance with the provisions of Section 901, et seq. of Article 18, Chapter X, Part II of the San Francisco Municipal Code (Public Works Code), the Board of Supervisors does hereby create the following underground district:

Underground District No. 353

(Mid-Lake Street District)

covering Lake Street from Park Presidio to 20th Avenue, 14th Avenue from Lake Street to dead end north, 15th Avenue from Lake Street to Presidio gate, 16th Avenue from Lake Street to dead end north, 18th Avenue from Lake Street to dead end north, 19th Avenue from Lake Street to dead end north, and 20th Avenue from Lake Street to dead end north.

Section 2. The undergrounding of facilities within this underground district is in the general public interest in that said action will eliminate a heavy concentration of overhead wires.

Section 3. All work in connection with the undergrounding of facilities lying within this underground district and subject to the laws with reference to underground districts is to be completed in accordance with the Department of Public Works' program; provided, however, that said work shall be commenced at such time or according to such priority as the Department of Public Works has established.

Section 4. The Board hereby requests that the utility companies providing the undergrounding of facilities within this underground district pay for up to 100 feet of each underground service lateral occasioned by the undergrounding.
