10 General Hospital lien in addition to the payment of \$110,000 approved by the Municipal  
11 Transportation Agency Board of Directors for a total settlement amount of \$550,000 and  
12 waiver of San Francisco General Hospital lien.

13 Section 2. The above-named action was filed in San Francisco Superior Court on  
14 May 5, 2004, and the following parties were named in the lawsuit: Lucia Wong, plaintiff; City  
15 and County of San Francisco, defendant.


