3 **Motion suspending Rule 5.42 of the Rules of Order of the Board of Supervisors to allow**  
4 **the Board of Supervisors to consider, without waiting 30 days after its introduction,**  
5 **Ordinance amending Chapter 23 of the Administrative Code regarding real property.**

7 WHEREAS, Rule 5.42 of the Rules of Order of the Board of Supervisors requires that  
8 when a measure is introduced that would create or revise major City policy, the measure shall  
9 not be considered until at least 30 days after the day of the measure's introduction; and,

10 WHEREAS, Rule 4.38 of the Rules of Order of the Board allows Rule 5.42 to be  
11 suspended by the affirmative vote of eight members of the Board, unless there be less than  
12 eight members present, in which case the unanimous consent of the members present, but  
13 not less than six members, shall be required; and

14 WHEREAS, The members of the Board of Supervisors wish to suspend the operation  
15 of Rule 5.42 with regard to the consideration of File No. 001965, Ordinance amending  
16 Chapter 23 of the Administrative Code regarding real property; and

17 WHEREAS, If this motion is adopted, File No. 001965 will be heard at the regularly  
18 scheduled Audit and Government Efficiency Committee meeting of December 5, 2000, which  
19 is 29 days after the legislation was introduced, only one day short of the 30 days prescribed  
20 by Rule 5.42; now, therefore, be it

21 MOVED, That the Board of Supervisors of the City and County of San Francisco, as  
22 allowed by Rule 4.38 of its Rules of Order, hereby suspends the operation of Rule 5.42 of its  
23 Rules of Order from operating with regard to the Board's consideration of this amendment of  
24 Chapter 23 of the Administrative Code.
