4 **Resolution authorizing the San Francisco Planning Department to apply for a planning**
5 **grant from the State of California Sustainable Communities Planning Grant and**
6 **Incentives Program under the Safe Drinking Water, Water Quality and Supply, Flood**
7 **Control, River and Coastal Protection Bond Act of 2006 (Proposition 84) to complete a**
8 **Greenway Network Plan.**

10 WHEREAS, The Legislature and Governor of the State of California have provided
11 funds for the program shown above; and

12 WHEREAS, The Strategic Growth Council has been delegated the responsibility for the
13 administration of this grant program, establishing necessary procedures; and

14 WHEREAS, Said procedures established by the Strategic Growth Council require a
15 resolution certifying the approval by the City's governing board before submission of said
16 application to the State; and

17 WHEREAS, The Planning Department, if selected, will enter into an agreement with the
18 State of California to carry out the development of a Green Network Plan; now, therefore, be it

19 RESOLVED, The Board of Supervisors approves the filing of an application for the
20 Greenway Network Plan in order to become a sustainable community; and, be it

21 FURTHER RESOLVED, The Planning Department understands the assurances and
22 certification in the application; and, be it

23 FURTHER RESOLVED, The Planning Department will have sufficient funds to develop
24 the Proposal or will secure the resources to do so; and, be it

1 FURTHER RESOLVED, The Proposal will comply with any applicable laws and
2 regulations; and, be it

3 FURTHER RESOLVED, The Director of the Planning Department, or a designee, is
4 hereby authorized and empowered to execute in the name of the City and County of San
5 Francisco all necessary applications, contracts, payment requests, agreements and
6 amendments hereto for the purpose of securing grant funds and to implement and carry out
7 the purposes specified in the grant application; and, be it

8 FURTHER RESOLVED, That the City and County of San Francisco authorizes the
9 submittal of additional grant applications by the Planning Department to the Strategic Growth
10 Council for all available grants and this resolution shall remain in effect for five (5) years.




