5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
6 and the San Francisco Traffic Code, the following regulations governing the parking of
7 vehicles are hereby enacted or rescinded as designated below:

9 **PARKING METERS, 2-HOUR, 9 AM TO 6 PM, MONDAY THROUGH FRIDAY - RESCIND**
10 **PARKING METERS, 2-HOUR, 9 AM TO 6 PM, MONDAY THROUGH SATURDAY -**
11 **ESTABLISH**

12 Bryant Street, west side, between 18th and Mariposa Streets (correction to operation times)

13 **TOW-AWAY, NO PARKING - RESCIND**
14 **METERED MOTORCYCLE PARKING - ESTABLISH**

15 Jessie Street, south side, from 4th Street to 54 feet westerly (approximately 14 metered motorcycle stalls)

16 Categorically exempt from Environmental Review Class
17 1(c)(9) changes in the traffic and parking regulations
18 where such changes do not establish a higher speed
19 limit or result in more than a negligible increase in the
20 use of the street.


