3 AUTHORIZING THE DEPARTMENT OF PUBLIC HEALTH, COMMUNITY HEALTH NETWORK  
4 (CHN), TO ENTER INTO AN AGREEMENT WITH UCSF STANFORD HEALTH CARE (UCSF)  
5 WHICH DOES NOT INCLUDE INTELLECTUAL PROPERTY INDEMNIFICATION AND FALSE  
6 CLAIMS CLAUSES TO PROVIDE ADMINISTRATIVE SERVICES FOR UCSF PURSUANT TO ITS  
7 CONTRACT WITH THE SAN FRANCISCO HEALTH PLAN FOR THE PROVISION OF SERVICES  
8 TO MEDI-CAL BENEFICIARIES; RETROACTIVE TO JANUARY 1, 2000.

10 WHEREAS, CHN has negotiated an agreement with UCSF Stanford Health Care to  
11 provide administrative services for UCSF pursuant to its contract with the San Francisco Health Plan for  
12 the provision of services to Medi-Cal beneficiaries; and,

13 WHEREAS, In turn, UCSF will pay CHN an administrative fee equal to 11 percent of the  
14 monthly capitation revenues received from San Francisco Health Plan for the first year of the agreement,  
15 and thereafter, 10 percent of the monthly capitation revenues received from San Francisco Health Plan to  
16 cover the expenses incurred by CHN in providing these administrative services; and,

17 WHEREAS, As a condition of receiving the funds, UCSF requires the City to enter into an  
18 agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in  
19 File No. 000291; and,

20 WHEREAS, The Agreement does not contain certain provisions described below, which are  
21 required under the Administrative Code unless waived by the Board of Supervisors; now, therefore, be it

22 RESOLVED, That the Department of Public Health, CHN, is hereby authorized to enter into an  
23 agreement with UCSF Stanford Health Care, to provide administrative services for UCSF pursuant to its  
24 contract with the San Francisco Health Plan for the provision of services to Medi-Cal Beneficiaries; and,  
25 be it


1 FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement  
2 on behalf of the City; and, be it

3 FURTHER RESOLVED, That the Board of Supervisors hereby waives the requirement contained  
4 in Section 21.21 of the Administrative Code that the Agreement include an indemnification of the City by  
5 UCSF for the infringement of patent rights, copyright, trademark, and other intellectual property rights;  
6 and, be it

7 FURTHER RESOLVED, That the Board of Supervisors hereby waives the requirement that the  
8 Agreement include a paragraph reciting the false claim provisions contained in Section 21.35 of the  
9 Administrative Code; and, be it

10 FURTHER RESOLVED, That the Board of Supervisors authorizes the Director of Health to enter  
11 into similar agreements with UCSF if the contract recurs or is renewed.


