4 **and distilled spirits liquor license to Mazen Gaber Gad, doing business as On the**
5 **Run Market, located at 4800 California Street (District 1), will serve the public**
6 **convenience or necessity of the City and County of San Francisco, in accordance**
7 **with California Business and Professions Code, Section 23958.4; and requesting**
8 **that the California Department of Alcoholic Beverage Control impose conditions**

11 WHEREAS, The Mazen Gaber Gad is seeking the transfer of a Type-21 off-sale
12 general beer, wine, and distilled spirits liquor license to do business as On the Run
13 Market located at 4800 California Street (District 1); and

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero protests and zero letters of
17 support with the Department of Alcoholic Beverage Control under California Business
18 and Professions Code, Section 24013, and recommends that the Department of
19 Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the
21 following: 1) petitioner(s) shall actively monitor the area under their control in an effort
22 to prevent the loitering of persons on any property adjacent to the licensed premises as
23 depicted on ABC-257 dated November 5, 2018; 2) sales, service, and consumption of
24 alcoholic beverages shall be permitted only between the hours of 8:00 a.m. and 10:00

1 p.m. daily; and 3) no distilled spirits shall be sold in bottles or containers of less than 50
2 milliliters; now, therefore, be it

3 RESOLVED, That in accordance with California Business and Professions Code,
4 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
5 hereby determines that the transfer of a Type-21 off-sale general beer, wine, and
6 distilled spirits liquor license to Mazen Gaber Gad, doing business as On the Run
7 Market, located at 4800 California Street (District 1), will serve the public convenience
8 or necessity of the City and County of San Francisco; and, be it

9 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
10 San Francisco hereby endorses and adopts the recommendations of the Police
11 Department listed above and recommends that the Department of Alcoholic Beverage
12 Control issue the license with those conditions.
