3 **Resolution determining that the transfer of a Type 21 off-sale general alcoholic**  
4 **beverage control license from 681 Third Street to 699 Third Street (District 6) to**  
5 **Joseph Kim for the Third & Townsend Corner Store will serve the public**  
6 **convenience and necessity of the people of the City and County of San**  
7 **Francisco, in accordance with Section 23958.4 of the California Business and**  
8 **Professions Code; with conditions.**

10 WHEREAS, Joseph Kim is seeking transfer of a Type 21 off-sale general  
11 alcoholic beverage control license for the Third & Townsend Corner Store, located at  
12 699 Third Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly  
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21  
20 off-sale general alcoholic beverage control license from 681 Third Street to 699 Third  
21 Street (District 6) for Joseph Kim for the Third & Townsend Corner Store will serve the  
22 public convenience and necessity of the people of the City and County of San  
23 Francisco.

24 Conditions: (1) Sales and service of alcoholic beverages shall be permitted only  
25 between the hours of 7:00 a.m. and 6:30 p.m. each day of the week; (2) The petitioner

1 shall be responsible for maintaining free of litter the area in front of and adjacent to the  
2 premises over which they have control; (3) No wine shall be sold with an alcoholic  
3 content greater than 15% by volume; (4) Wine shall not be sold in bottles or containers  
4 smaller than 750 ml. and wine coolers shall not be sold in units less than a four pack;  
5 (5) No person under the age of 21 shall sell or package alcoholic beverages.




