2 COMMENDING THE GOVERNOR, LIEUTENANT GOVERNOR AND ALL PARTIES
3 INVOLVED IN REACHING AN AGREEMENT RESOLVING THE APPEAL OF PROPOSITION
4 187.

6 WHEREAS, In the best interests of all Californians, an agreement was reached
7 regarding the appeal of Proposition 187 by the State of California; and,

8 WHEREAS, The agreement symbolizes an end to the divisive, anti-immigrant, political
9 campaign which began in 1987; and,

10 WHEREAS, When approved by the court, the agreement voids any requirement that
11 local law enforcement authorities, school administrators and social and medical workers turn
12 in suspected undocumented immigrants to federal and state authorities; and,

13 WHEREAS, The agreement ends the battle to allow all children in California to attend
14 public school; and,

15 WHEREAS, The agreement recognizes the importance to public health and safety of
16 providing health care to all residents of California; and,

17 WHEREAS, The agreement is a positive step for all Californians; now, therefore, be it,

18 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
19 does hereby commend and congratulate the work of all the individuals and organizations
20 involved in resolving the litigation on Proposition 187; and, be it

21 FURTHER RESOLVED, That the Board of Supervisors of the City and County of San
22 Francisco does hereby commend and congratulate the Governor of the State of California,
23 Joseph Graham Davis, Jr. and the Lieutenant Governor of the State of California, Cruz M.


