

1 APPROVING ABANDONMENT OF A PORTION OF THE SERVICE ON LINE 56-RUTLAND.
2 ESTABLISHMENT OF SUBSTITUTE SERVICE TO VISITACION VALLEY MIDDLE SCHOOL.

3 WHEREAS, The Board of Supervisors is in receipt of Public Transportation Resolution No.
4 99-053, adopted May 18, 1999, which resolution reads as follows:

5 WHEREAS, Community residents and the school administration have requested that Muni provide
6 better transit access to Visitacion Valley Middle School, which is not conveniently accessible by
7 present Muni service; and,

8 WHEREAS, Activities at the middle school include the Beacon program which offers a range of
9 service to the community, including activities such as classes in English and citizenship; and,

10 WHEREAS, Muni staff have determined that the 56-RUTLAND is best suited to provide this service;
11 and,

12 WHEREAS, The San Francisco Unified School District has agreed to provide a paved area for a
13 stop, boarding area and possible terminal for the line; now, therefore, be it

15 RESOLVED, That the Public Transportation Commission does hereby authorize the Public
16 Transportation Department to abandon the portion of the 56-RUTLAND diesel coach route on
17 Sunnydale Avenue between Rutland Street and Bayshore Boulevard; on Bayshore between Arleta
18 Avenue and Sunnydale Avenue; on San Bruno Avenue between Wilde Street and Mansell; and on
19 the current northern terminal loop on Mansell, Girard, Olmstead and San Bruno; and, be it further

20 RESOLVED, That the Public Transportation Department is hereby authorized to establish new
21 service as follows:

22 From Executive Park via Thomas Mellon Circle, right Alana, right Executive Park Drive,
23 left Blanken, right San Bruno, left Wilde, left Delta, left Tioga, right Rutland, right
24 Sunnydale, right Hahn, left Visitacion to terminal at Visitacion Valley Middle School upper
25 parking lot;

RESOLVED, That the Board of Supervisors does, hereby, approve the aforementioned partial abandonment of service on line 56-RUTLAND and the establishment of substitute service.
