

1 [Parking Regulations.]

3 **Resolution enacting and rescinding parking regulations at various locations.**

4

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
6 and the San Francisco Traffic Code, the following regulations governing the parking of
7 vehicles are hereby enacted or rescinded as designated below:

8 **RESIDENTIAL PERMIT PARKING AREA "W" (2-HOUR TIME LIMIT, 8 AM - 6 PM, MONDAY THROUGH FRIDAY) - ESTABLISH**

9

10 Rhode Island Street, both sides, between 25th and 26th Streets (1400).

11 **TOW-AWAY, NO PARKING ANYTIME - ESTABLISH**

12 Marina Boulevard, north side, from Laguna Street to 20 feet westerly.

13 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

14

15 Irving Street, north side, from 9th Avenue to 24 feet easterly (removes one parking
meter space).

16 **PARKING METER AREA NO. 3 (1-HOUR PARKING TIME LIMIT, 9 AM - 6 PM, MONDAY THROUGH SATURDAY) - RESCIND**

17

18 **PARKING METER AREA NO. 3 (2-HOUR PARKING TIME LIMIT, 9 AM - 6 PM, MONDAY THROUGH SATURDAY) - ESTABLISH**

19 Eddy Street, both sides, between Franklin Street and Van Ness Avenue (800 block)

20 **1-HOUR PARKING LIMIT, 7 AM TO 6 PM, MONDAY THROUGH SATURDAY - RESCIND**
21 **2-HOUR PARKING LIMIT, 7 AM TO 6 PM, MONDAY THROUGH SATURDAY - ESTABLISH**

22 Eddy Street, both sides, between Franklin and Gough Streets (900 block)

23 **TOW-AWAY, NO PARKING ANYTIME - ESTABLISH**

24 Sickles Avenue, south side, from Alemany Boulevard to 120 feet westerly.

2 **RESIDENTIAL PERMIT PARKING AREA "W" (2-HOUR TIME LIMIT, 8 AM - 6 PM,**
3 **MONDAY THROUGH FRIDAY) - ESTABLISH**

4 Bryant Street, both sides, between 20th and 21st Streets (2200 block).

5
6 Categorically exempt from Environmental Review Class
7 1(c)(9) changes in the traffic and parking regulations
8 where such changes do not establish a higher speed
9 limit or result in more than a negligible increase in the
10 use of the street.
