10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby

12 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-15-549595 by the
13 payment of \$60,000. The lawsuit involves an employment dispute.

17 (Plaintiff), Almudena Marcos Martin (Plaintiff), City and County of San Francisco (Defendant).


