3 **Resolution authorizing the Department of the Environment to retroactively accept and**
4 **expend a grant in the amount of \$11,175 from the California Integrated Waste**
5 **Management Board for the purpose of increasing proper disposal of Household**
6 **Hazardous Waste and supporting San Francisco's involvement in the California**
7 **Product Stewardship Council.**

9 WHEREAS, The people of the State of California have enacted the California Oil
10 Recycling Enhancement Act that provides funds to cities and counties for establishing and
11 maintaining Household Hazardous Waste collection programs; and,

12 WHEREAS, the California Integrated Waste Management Board (CIWMB) has been
13 delegated the responsibility for the administration of the program within the state, setting up
14 necessary procedures governing application by cities and counties under the program; and,

15 WHEREAS, the City and County of San Francisco applied for and was awarded funds
16 to promote its Household Hazardous Waste disposal programs and support its involvement in
17 the California Product Stewardship Council; and,

18 WHEREAS, the California Product Stewardship Council promotes the production of
19 less toxic materials, thus reducing the burden on local governments to provide management
20 of toxic waste; and,

21 WHEREAS, the grant is a non-competitive grant that is available to the City and County
22 of San Francisco from the California Integrated Waste Management Board; and,

23 WHEREAS, The grant budget does not include indirect costs; and,


24 WHEREAS, This grant does not require an ASO amendment; now, therefore, be it




1 RESOLVED, That the City and County of San Francisco authorizes the Department of
