Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Park Code is hereby amended by adding Section 12.15, to read as follows:

**SEC. 12.15. DAY CAMP FEES.**

The following fees shall be charged for Recreation and Park Department day camps:

<u>Silver Tree Camp</u>	<u>85.00</u>
<u>Camp Gourmet</u>	<u>85.00</u>
<u>Athletic Day Camp (2 weeks total)</u>	<u>170.00</u>
<u>Pacific Art Camp (2 weeks total)</u>	<u>170.00</u>
<u>Pacific Art Camp (ages 4-6)</u>	<u>42.00</u>






