THE FINAL WORD ON PROPOSITION 187.

WHEREAS, Proposition 187, passed by the voters in 1994, seeks to deny public educational, social and health services to immigrants who are in California illegally; and,

WHEREAS, On March 17, 1998, Judge Mariana Pfaelzer of the United States District Court for the Central District of California issued her final ruling in the cases challenging Proposition 187, striking down most of the initiative; and,

WHEREAS, Former Governor Pete Wilson, a longtime champion of Proposition 187, filed an appeal to Judge Pfaelzer's ruling with the Ninth Circuit Court of Appeals; and,

WHEREAS, There is no legal requirement that Governor Davis continue the Wilson appeal in defense of Proposition 187; and,

WHEREAS, Proposition 187's provisions denying children public education and health care threaten public health and safety; and,

WHEREAS, Proposition 187's denial of educational rights directly violates the 1982 decision in <u>Plyler v. Doe</u>, 457 U.S. 202, in which the Supreme Court held that denying children education on the basis of immigration status violates the Fourteenth Amendment of the Constitution; and,
