6 **and County of San Francisco, et al.; the lawsuit involves alleged personal injury from**
7 **collision with City vehicle.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled John LaSalle v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-21-589176 by the
13 payment of \$489,000. The lawsuit involves alleged personal injury from collision with City
14 Vehicle.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 January 21, 2021, and the following parties were named in the lawsuit: John LaSalle, Plaintiff;
17 City and County of San Francisco, Frederick Gonzales, Defendants.
