- **Contract 1000005805 (TC 77524)**

- Supplier: Buckles-Smith Electric Co
- Awarded in July 2017 after a competitive solicitation
- Discounts range from 15% to 99% off the offered manufacturers/brands and product types.
- Current NTE \$17,446,868, ending on June 30, 2024
- **Proposed Amendment:** Increase NTE by \$2,053,132, to **\$19,500,000**

- **Contract 1000023404 (TC 77001)**

- Supplier: Alameda Electrical Co.
- Awarded in December 2017 after a competitive solicitation
- Discounts range from 5% to 98% off the offered manufacturers/brands and product types.
- Current NTE \$9,900,00, ending on April 30, 2024
- **Proposed Amendment:** Increase NTE by \$600,000, to **\$10,500,000**

# Justification

---

- OCA has been working on rebidding both contracts since May 2023.
- Numerous factors have impeded OCA's ability to issue a new solicitation in its anticipated timeline, including staffing limitations and data constraints.
- OCA expects to issue a new solicitation in early 2024 with new contracts in place by June 2024.
- The requested increase to each Contract's NTE will ensure City departments can continue to use these contracts through their end dates of April 30, 2024(Alameda Electrical Co, PS 1000023404) and June 30, 2024 (Buckles-Smith Electric Co, PS 1000005805) while OCA works to replace each contract through a new solicitation.
