13 WHEREAS, The City Planning Department has verified that the area is properly
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 **RESOLVED**, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 48
20 on-sale general public premises license from 3653 Buchanan Street to 1028 Geary
21 Street (District 6) for Neeraj Gore for Lunar Productions LLC, dba "Element" bar and
22 lounge will serve the public convenience and necessity of the people of the City and
23 County of San Francisco.

24 Conditions: (1) Petitioner shall regularly police the area under their control in an
25 effort to prevent the loitering of persons about the premises; (2) The petitioner shall be

1 responsible for maintaining free of litter the area adjacent to the premises over which
2 they have control; (3) Entertainment provided shall not be audible beyond the area
3 under control of the licensee.


