14 future tax measure passed by the voters will generate sufficient additional revenue
15 to fund the cost of employing Full-Duty Sworn Officers at specified minimum staffing

5 assign to any other person(s) under Municipal Elections Code, Section 550(c) and (d), to
6 prepare and submit the proponent/opponent's ballot argument(s) and/or respective rebuttal
7 argument(s).
