2 have regularly scheduled meetings during weeks when holidays occur, except that for
3 Thanksgiving the meeting cancellations will be the week following the holiday, and regular
4 meetings shall not be scheduled during the first weeks of March, April (in honor of the birthday
5 of Cesar Chavez), June and August.]

6 **Motion amending Rule 6.2 of the Rules of Order of the Board of Supervisors to provide**
7 **that neither the Board of Supervisors nor any of its Committees shall convene regularly**
8 **scheduled meetings during ~~the week of the first Tuesday of each month~~ weeks when a**
9 **holiday occurs, effective beginning the week of May 26, 2003, except that regularly scheduled**
10 **Board and Committee meetings may be held on Monday through Wednesday of Thanksgiving**
11 **week, and shall not be scheduled during the week following Thanksgiving, nor during the**
12 **weeks of the first Tuesdays of March, April (in honor of the birthday of Cesar Chavez), June**
13 **and August.**

18 MOVED, That the Board of Supervisors of the City and County of San Francisco does
19 hereby amend Rule 6.2 to read as follows:

20 6.2 Regular Meetings of Board. Through January 27, 2003, the Board shall hold a
21 regular meeting in the Chamber in City Hall each week at 2:00 p.m. on Monday, unless it is a
22 holiday, in which case the meeting shall be held on the next regular business day. Effective
23 the week of February 2, 2003, the Board shall hold a regular meeting in the Chamber in City
24 Hall each week at 2:00 p.m. on Tuesday, unless it is a holiday, in which case the meeting
25 shall be held on the next regular business day. The Board shall not meet during the week
after Thanksgiving, between December 24 and December 31, inclusive, nor on any Monday

1 or Tuesday if the following day is a holiday, unless the Board, by majority vote, decides to
2 hold a meeting at these times. Neither the Board of Supervisors nor any of its Committees shall
3 convene regularly scheduled meetings during the week of the first Tuesday of each month,
4 effective with the week of May 6, 2003 weeks when a holiday occurs, effective beginning the
5 week of May 26, 2003, except that regularly scheduled Board and Committee meetings may
6 be held on Monday through Wednesday of Thanksgiving week, and shall not be scheduled
7 during the week following Thanksgiving. In addition, neither the Board nor any of its
8 Committees shall convene regularly scheduled meetings during the week of the first Tuesday
9 of March, June and August. Further, neither the Board nor any of its Committees shall
10 convene regularly scheduled meetings during the week of the first Tuesday of April, in honor
11 of the birthday (March 31) of Cesar Chavez.
