2 **Resolution declaring January 22, 2016, as William “Bill” Del Monte Day.**

4 WHEREAS, William “Bill” Del Monte lived on to be the age of 109, as an honorable
5 survivor of the 1906 San Francisco earthquake and fire, a tragic event in our city’s history; and

6 WHEREAS, Mr. Del Monte’s passing marked an end of an era, as he was the last
7 known survivor of the 1906 San Francisco earthquake and fire; and

8 WHEREAS, After being forced out of his home in North Beach after the 1906
9 earthquake – escaping in a horse-drawn carriage, he witnessed our City’s rise from the ashes
10 over a century of remarkable advances seeing it built better than ever; and

11 WHEREAS, As a San Francisco high school graduate and employee in his family’s
12 restaurant – Fior d’Italia – which his father founded in 1886 on Broadway Street and is still in
13 business today in North Beach, he experienced what makes our City so great – our people;
14 and

15 WHEREAS, Mr. Del Monte lived a fulfilling life by utilizing his own brilliance, and
16 enriching the lives of many others through his humor, and kindness; and

17 WHEREAS, Mr. Del Monte’s passions included playing the stock market and running a
18 theater in the City for several years; and

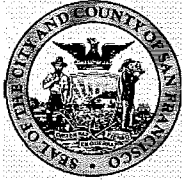
19 WHEREAS, Mr. Del Monte was a dedicated individual to not only his late wife Vera


