3 **Resolution declaring July 22, 2025, as Lady Gaga Day in the City and County of San**
4 **Francisco.**

5
6 WHEREAS, Lady Gaga, born Stefani Joanne Angelina Germanotta, is an
7 internationally celebrated singer, songwriter, actress, and philanthropist who has sold over
8 124 million records and is known as one of the most influential artists in history; and

9 WHEREAS, Critics have described her performances as “talented, brilliant, incredible,
10 amazing, show-stopping, spectacular, never the same, totally unique, completely not ever
11 been done before, unafraid to reference or not reference”; and

12 WHEREAS, She has amassed six number-one studio albums including: *The Fame*
13 (2008), *The Fame Monster* (2009), *Born This Way* (2011), *Artpop* (2013), *Joanne* (2016),
14 *Chromatica* (2020), and most recently *MAYHEM* (2025); and

15 WHEREAS, Gaga left her heart in San Francisco after releasing two jazz albums,
16 *Cheek to Cheek* (2014) and *Love for Sale* (2021) with 20-time Grammy Award winning singer
17 Tony Bennett; and

18 WHEREAS, Gaga has gained praise for her leading roles in the anthology series
19 *American Horror Story: Hotel* (2015) and the films *A Star is Born* (2018) and *House of Gucci*
20 (2021); and

21 WHEREAS, Her accolades include 14 Grammy Awards, a Sports Emmy Award, two
22 Golden Globe Awards and an Academy Award; and

23 WHEREAS, She has frequently advocated for LGBTQ+ rights, mental health
24 awareness, rights for victims of sexual assault; and

1 WHEREAS, Through her philanthropic efforts, she has helped raise \$127 million to
2 benefit the World Health Organization's COVID-19 Solidarity Response Fund and millions to
3 support recovery for victims of the 2025 Southern California Wildfires; and

4 WHEREAS, Embarking on a world tour has made her feel as though she's going from
5 no sleep, bus, club, another club, another club, plane, next place, no sleep, with no fear, and
6 nobody who believed in her; and

7 WHEREAS, In 2020, Gaga brought her Chromatica Ball World Tour to San Francisco's
8 Oracle Park, where 40,000 "Little Monsters" put their paws up and said "yaaasss Gaga"; and

9 WHEREAS, After being in love with Judas and getting caught in a Bad Romance with
10 Alejandro, Gaga became engaged to her San Francisco-based fiancé Michael Polansky who
11 co-wrote and produced songs with her as part of their Folie à Deux; and

12 WHEREAS, In April of 2025, Gaga headlined Coachella and paid the toll to the angels
13 through stunning performances of songs including "*Abracadabra*", "*How Bad Do U Want Me*",
14 and "*Vanish Into You*"; and

15 WHEREAS, Her collaboration with Bruno Mars, "Die With a Smile" became the longest-
16 running #1 hit on Spotify's daily global chart and broke records for the fastest song to reach 1
17 and 2 billion streams on the platform; and

18 WHEREAS, In May of 2025, she performed at Copacabana Beach in Rio de Janeiro,
19 Brazil to a crowd of 2.5 million people, setting a new record for the largest concert attendance
20 by a female artist; and

21 WHEREAS, Gaga is set to bring her MAYHEM Ball World Tour to San Francisco's
22 Chase Center on July 22, 24, and 26, 2025; and

23 WHEREAS, San Francisco will benefit from increased business and tourism associated
24 with these tour dates; and

1 WHEREAS, The Board of Supervisors of the City and County of San Francisco has
2 previously passed Resolutions celebrating other touring artists, including Taylor Swift
3 Weekend in July of 2023; and

4 WHEREAS, There could be 100 people in a room and 99 don't believe in you, but all it
5 takes is one legislative aide who believes in you to draft a Resolution; now, therefore, be it

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 declares that July 22, 2025, shall be recognized as Lady Gaga Day; and, be it

8 FURTHER RESOLVED, That the Board of Supervisors of the City and County of San
9 Francisco recognizes and celebrates the contributions of Lady Gaga to our City.
