4 **Resolution urging the Mayor's Office to recommend reallocating funds from under-**  
5 **performing programs funded through the Children's Fund to fund alternative programs**  
6 **to summer school programs. Furthermore, the alternative programs would be**  
7 **administered by the Department of Children Youth & Their Families.**

9 WHEREAS, Due to expected cuts in California State funding for summer school  
10 programs the San Francisco Unified School District (SFUSD) has announced that it is  
11 significantly cutting back its summer school program; and,

12 WHEREAS, The paring down of, or canceling completely, some programs will leave  
13 approximately 8,000 elementary school students and 4,000 middle and high-school students  
14 without summer school and could have a devastating effect on students who will be left with  
15 no alternative; and,

16 WHEREAS, The City should provide alternative programs for students who will go  
17 without summer school as a result of state budget cuts; and therefore, be it,

18 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
19 urge the Mayor's Office to recommend reallocating funds from under-performing programs  
20 funded through the Children's Fund to fund alternative programs for students who will go  
21 without summer school as a result of state budget cuts; and therefore be it,

22 FURTHER RESOLVED, That these after and summer school programs would be  
23 administered by the Department of Children Youth & Their Families; and be it


