

1 [Contract Agreement - Mythics, LLC. - Oracle Products - Not to Exceed \$94,587,831]

3 **Resolution authorizing the Department of Technology to enter into the Third**
4 **Amendment to the agreement between the City and County of San Francisco and**
5 **Mythics, LLC, for the purchase of Oracle products and cloud computing solutions, to**
6 **increase the agreement by \$34,587,831 for a total amount not to exceed \$94,587,831;**
7 **and to extend the term for 31 months from April 30, 2026, for a total agreement term of**
8 **May 1, 2021, through November 30, 2028.**

10 WHEREAS, Charter, Section 9.118(b), requires the Board of Supervisors to
11 approve by Resolution contracts estimated to cost the City \$10,000,000 or more; and

12 WHEREAS, A request for proposal ("RFP") was issued by Maricopa County, Arizona
13 for a Reseller for Oracle products and cloud services on behalf of all state and local
14 governments, and the county selected Mythics as the highest qualified scorer pursuant to the
15 RFP; and

16 WHEREAS, Pursuant to Administrative Code, Section 21.16, the Department may
17 utilize the results of a competitive solicitation by another public agency; and

18 WHEREAS, The City through the Department of Technology ("Department") selected
19 Mythics to procure Oracle products and cloud computing solutions, including PeopleSoft
20 applications on an as-needed basis through an enterprise agreement; and

21 WHEREAS, On April 20, 2021, the Board of Supervisors pursuant to Charter,
22 Section 9.188(b), under Resolution No. 161-21, approved the Agreement with Mythics to
23 provide these Oracle products for five years, from May 1, 2021, through April 30, 2026, for an
24 amount not to exceed \$60,000,000 with one five-year option to extend; and

1 WHEREAS The Department amended the agreement on April 10, 2023, and
2 September 25, 2024, to add changes to the terms, which did not increase the cost of the
3 agreement or extend the term of the agreement; and

4 WHEREAS, The Department wishes to continue to purchase Oracle products under
5 that agreement; now, therefore, be it

6 RESOLVED, That the Board of Supervisors authorizes the Department of Technology
7 and Director of the Office of Contract Administration to execute the Third Amendment to the
8 agreement with Mythics for an additional 31 months with a maximum guaranteed cost of
9 \$94,587,831 in substantially the form on file with the Clerk of the Board of Supervisors, in File
10 No. 260237, with such changes or modifications, including without limitation modifications to
11 the exhibits, as may be acceptable to the Department and the City Attorney, and which do not
12 materially increase the obligations and liabilities of the City; and, be it

13 FURTHER RESOLVED, That within 30 days of the agreement being fully
14 executed by all parties, the Director of the Department of Technology and the Director of the
15 Office of Contract Administration shall provide the final contracts to the Clerk of the Board for
16 inclusion into the official file.
