
At our **Monday, August 17, 2020 special meeting**, the Youth Commission unanimously voted to support the following motion:

BOS File No. 200796 [Hearing - Supportive Housing Vacancies]

The Youth Commissioners also voted to include the following questions to be asked at the hearing as well as recommendations:

- Recommendation: the Youth Commission strongly advises the City to complete the 2015 TAY Housing plan before making more promises on filling vacancies
- Recommendation: vacancies should be broken down by category to get a sense of how big a problem this is for Transitional Aged Youth, specifically, as well as with adults
- Questions-language access concerns and how community members can apply for housing:
 - How do the departments provide language assistance to ensure that all persons have access to permanent supportive housing?
 - What is the language access plan for the department and how have they made their mark on communities?
 - Who is being served?
 - Who is being underserved?
- Questions-roles of different departments:
 - What stock does the Housing Authority oversee?
 - How is their application process different from the rest of housing stock?
 - How is the Housing Authority functions different from MOHCD?
- Questions-COVID19 related:
 - How are families able to access these social services in COVID-19 time with limited access to resources?
 - How would changes to social services change during COVID19?
 - Do any departments have a plan while they are building units so that families and community members can have access to social services?
