3 **Ordinance repealing San Francisco Municipal Administrative Code Section 10C.8-1,**  
4 **providing for waiver of vehicle storage fees for vehicles reported stolen, which are**  
5 **owned by residents of the City and County of San Francisco.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The San Francisco Administrative Code is hereby amended by repealing  
11 Section 10C.8-1, to read as follows:

12 ~~SEC. 10C.8-1. EXEMPTION FROM PAYMENT FOR TOW AND STORAGE FEES ON~~  
13 ~~STOLEN VEHICLES OWNED BY RESIDENTS OF THE CITY AND COUNTY OF SAN~~  
14 ~~FRANCISCO.~~

15 ~~————The owner or person in lawful possession of a vehicle that has been stolen and~~  
16 ~~recovered within the City and County of San Francisco shall be exempt from paying fees,~~  
17 ~~charges or costs imposed for the towing or storage of stolen vehicles or the amount charged~~  
18 ~~for removal of components of a stolen vehicle provided:~~

19 ~~————(a)————The owner or person in lawful possession of the stolen vehicle is a~~  
20 ~~resident of the City and County of San Francisco and shows proof of residency within the City~~  
21 ~~and County of San Francisco to the San Francisco Police Department;~~

22 ~~————(b)————The owner or person in lawful possession of the stolen vehicle has~~  
23 ~~reported the vehicle as stolen to the San Francisco Police Department prior to applying for the~~  
24 ~~exemption.~~

1           ~~\_\_\_\_\_ Should the owner or person in lawful possession of the stolen vehicle meet the~~  
2 ~~requirements set forth in Section 10C.8-1(a) and (b) the Chief of Police or his or her designee~~  
3 ~~shall issue a voucher in the amount equal to the total of all fees, charges and costs for towing~~  
4 ~~and storage directed to the person, firm or corporation, having custody of the vehicle. Said~~  
5 ~~voucher shall be on a form jointly approved by the Controller and the Chief of Police.~~

6           ~~\_\_\_\_\_ Upon presentation of this voucher to the person, firm or corporation having~~  
7 ~~custody of the vehicle, the vehicle shall be repossessed by the person presenting the voucher~~  
8 ~~without payment.~~

9           ~~\_\_\_\_\_ The person, firm or corporation receiving the voucher may present the voucher~~  
10 ~~to the office of the Police Department designated by the Chief of Police for payment of the~~  
11 ~~fees stated on the voucher.~~
