6 WHEREAS, The Board of Supervisors may on occasion request that the Legislative
7 Analyst review legislation or policy issues, aid the Board's task forces and advisory
8 committees and perform similar assistance; and

9 WHEREAS, Such assistance should only be by majority approval of the Board as a
10 whole; and

11 WHEREAS, A Rule of Order of the Board is necessary to facilitate this kind of
12 directive to the Legislative Analyst; now, therefore, be it

13 MOVED, That the Board of Supervisors hereby amends its Rules of Order by adding
14 Rule 3.12 concerning the Board agenda to read as follows:
15 Rule 3.12 Approval of Requests of the Legislative Analyst.

16 This portion of the agenda allows any Board member to request that the Legislative
17 Analyst provide assistance to the Board as a whole including, but not limited to: analyzing
18 introduced legislation, analyzing policy issues and providing assistance to Board of
19 Supervisors' task forces and advisory committees. Such requests shall be listed under this
20 agenda heading in the order received by the Clerk of the Board including the title of relevant
21 legislation, if applicable. Any request of the Board as a whole to the Legislative Analyst
22 requires six affirmative votes; and be it

23 FURTHER MOVED, That Rule 3.12 concerning the Imperative Calendar
24 be renumbered to Rule 3.13, 3.13.1 and 3.13.2.


