As a career public servant and community volunteer, I have the ability to bring a unique perspective to the City's Airport Facilities Naming Advisory Committee. During my tenure as Airport Director, I managed the establishment of the Airport Commission's Official Naming Policy (adopted by the San Francisco Airport Commission in September of 2013) and have a thorough understanding of Airport operations and facilities. In addition to my career at the Airport, I am currently a Buddhist Insight Meditation Teacher and lead a weekly sitting group in my neighborhood, as well as a LGBTQ+ sitting group in Redwood City, and teach on retreats at meditation centers.

I was appointed the Director of the San Francisco International Airport in 1995 after serving as the Airport's deputy airport director for business and finance. In all, I spent 35 years at SFO until my retirement last year, and was named the longest continuously serving airport director in the country. In the time that I was at SFO, I oversaw the completion of a \$3.5 billion capital plan that included the building of the international terminal, a BART extension to the airport, and the Air Train people mover, among other projects.

NOTICE IS HEREBY GIVEN of the following vacancy:

**Vacant seat 9**, succeeding Nick Smith, resigned, must be a member of the public, and must not be a member of any other board or commission of the City, for an indefinite term.

Report: No later than three calendar months after its inaugural meeting, the Committee shall transmit a written report to the Board of Supervisors and the Mayor recommending the naming of a terminal at the Airport as Harvey Milk Terminal or, in the case of the International Terminal, Harvey Milk International Terminal. The report shall identify which terminal the Committee recommends naming after Harvey Milk, and shall provide the reasons the Committee recommends that terminal.

After transmitting its initial report, the Committee may transmit additional written reports to the Board of Supervisors and the Mayor recommending renaming other Airport terminals, towers and boarding areas.

Sunset Date: This Committee shall terminate, on the last day of the 18<sup>th</sup> calendar month after the inaugural meeting.

**Board Qualifications:**

The Airport Facilities Naming Advisory Committee (the "Committee") was established to make recommendations to the Board of Supervisors and the Mayor regarding naming a terminal of the San Francisco International Airport (the "Airport") after Harvey Milk. Upon receipt of the Committee's recommendations, it is the intent of the Board to adopt legislation naming a terminal of the Airport after Harvey Milk. In addition, the Committee may make additional recommendations to the Board regarding naming other terminals, towers and boarding areas at the Airport, consistent with the provisions of Article XXVII.

The Committee shall consist of nine members. The Mayor shall appoint five members to hold Seats 1 through 5, and the Board of Supervisors shall appoint four members to hold Seats 6 through 9.

No member of the Committee may during his or her tenure be a member of any other board or commission of the City.

Members of the Committee shall serve for the life of the Committee; provided, however, that each appointing authority may remove any of its appointees to the Committee at any time with or without cause.

If a vacancy occurs in any seat on the Committee, the appointing authority for the vacated seat shall appoint a successor.

BOARD OF SUPERVISORS

The Committee shall hold its inaugural meeting not more than 30 days after a quorum of the Committee has been appointed. There shall be ten days' notice of the inaugural meeting. During the 18 calendar months following the inaugural meeting, the Committee shall hold a regular meeting not less than once every calendar month. The Committee may meet more often as determined by the Committee.

The Airport Department shall provide administrative support to the Committee. All City departments, commissions, boards, and agencies shall cooperate with the Committee in conducting its business.

Annual Report: No later than three calendar months after its inaugural meeting, the Committee shall transmit a written report to the Board of Supervisors and the Mayor recommending the naming of a terminal at the Airport as Harvey Milk Terminal or, in the case of the International Terminal. Harvey Milk International Terminal. The report shall identify which terminal the Committee recommends naming after Harvey Milk, and shall provide the reasons the Committee recommends that terminal.

After transmitting its initial report, the Committee may transmit additional written reports to the Board of Supervisors and the Mayor recommending renaming other Airport terminals, towers and boarding areas.

Sunset: This Article shall expire by operation of law, and the Committee shall terminate, on the last day of the 18th calendar month after the inaugural meeting of the Committee. After that date, the City Attorney shall cause this Article to be removed from the Administrative Code.
