6 WHEREAS, Keith R. Sagers, dba SF Student Jobs Coalition is a State of California  
7 Limited Liability Corporation that operates pedicabs in San Francisco; and,

8 WHEREAS, SF Student Jobs Coalition was issued License Number 13373 by the Port  
9 of San Francisco on February 21, 2003 to operate on its property; and,

10 WHEREAS, Section 39.09 of the Police Code states that permittees issued pedicab  
11 permits pursuant to the provisions of Article 39 shall file with the Board of Supervisors the  
12 fares per passenger charged for each trip; and,

13 WHEREAS, Section 39.09 further states that the Board of Supervisors may adopt,  
14 modify or reject the fare schedules submitted; and,

15 WHEREAS, SF Student Jobs Coalition has filed a fare schedule with the Board of  
16 Supervisors, as required under Section 39.09 of the Police Code; and,

17 WHEREAS, SF Student Jobs Coalition's proposed fare schedule, for two passengers,  
18 is the following: \$20.00 for Pier 39 to/from the Ferry Building, \$40.00 for Pier 39 to/from  
19 Townsend Street, \$45.00 for Pier 39 to/from the Ballpark (pending route approval), \$10.00 for  
20 Pier 33 to/from Pier 39, \$20.00 for Pier 33 to/from the Ferry Building, \$30.00 for Pier 33  
21 to/from Townsend Street, \$35 for Pier 33 to/from the Ballpark (pending route approval),  
22 \$20.00 for the Ferry Building to/from Townsend Street, \$25.00 for the Ferry Building to/from  
23 the Ballpark (pending route approval), \$15.00 for Pier 39 to/from Cable Cars, \$20.00 for Pier  
24 39 to/from Ghiradelli Square, \$30.00 for a tour of Fisherman's Wharf, \$30.00 for a tour of  
25

1 Chinatown, \$65 for a one hour tour, and \$6 per person for all fares for more than tow  
2 passengers; now, therefore be it

3 RESOLVED, that pursuant to Section 39.09 of the Police Code, the Board of  
4 Supervisors approves the fare schedule proposed by SF Student Jobs Coalition.
