17 Association (APTA) National Public Affairs and Community Relations Committee, and serves
18 on the association's Marketing & Communications Steering Committee; and

19 WHEREAS, Mr. Healy has served on the Board of Directors of the Oakland Visitors
20 and Conventions Authority and is a member of the Oakland Mayor's Marketing Board; and

21 WHEREAS, Mr. Healy has established a reputation of honest, fair, and professional
22 presentation of BART's activities to the media and the public; and

23 WHEREAS, Mr. Healy makes his home in the Montclair District of Oakland with his
24 wife, Joan Van Horn, and three children, Scott, Megan and Caitlin; and


