3 APPROVING TWO AUTOMATED TELLER MACHINE LEASES FOR THE EXISTING AND  
4 NEW INTERNATIONAL TERMINAL BUILDINGS BETWEEN TRAVELEX AMERICA, INC.  
5 AND THE CITY AND COUNTY OF SAN FRANCISCO, ACTING BY AND THROUGH ITS  
6 AIRPORT COMMISSION.

7 WHEREAS, The Airport Commission requested bids for two Automated Teller Machine  
8 Leases for the New International Buildings; and

9 WHEREAS, Travelex America, Inc. submitted a bid of \$240,500, as the minimum  
10 annual rent for the first year of each Lease; and

11 WHEREAS, Airport Commission staff determined that Travelex America, Inc. is the  
12 highest responsive bidder; and

13 WHEREAS, The Airport Commission awarded the Automated Teller Machine Leases  
14 for the New International Terminal Buildings to Travelex America, Inc. on December 21, 1999;  
15 and,

16 WHEREAS, The Airport Commission and Travelex America, Inc. have agreed to  
17 amend the two Automated Teller Machine (ATM) Leases to stipulate that if a court of  
18 competent jurisdiction deems Proposition F to be applicable to the operations provided for in  
19 the Leases, Travelex will abide by the provisions of Proposition F or cease its operations at  
20 the Airport; now, therefore, be it

21 RESOLVED, That the Board of Supervisors hereby approves the Automated Teller  
22 Machine Leases for the New International Terminal Buildings, copies of which are contained  
23 in the Board of Supervisors' file number 000235.
