3 **Ordinance authorizing settlement of the lawsuit filed by Lyn Rawles against the City**
4 **and County of San Francisco for \$200,000; the lawsuit was filed on December 4, 2020,**
5 **in San Francisco Superior Court, Case No. CGC-20-588157; entitled Lyn Rawles v. City**
6 **and County of San Francisco, et al.; the lawsuit involves an alleged civil rights**
7 **violation.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Lyn Rawles v. City and County of San
12 Francisco, San Francisco Superior Court, Case No. CGC-20-588157 by the payment of
13 \$200,000. The lawsuit involves an alleged civil rights violation.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 December 4, 2020, and the following parties were named in the lawsuit: Plaintiff: Lyn Rawles;
16 Defendants: City and County of San Francisco, Deputy Bloom, Deputy Rodriguez, Deputy
17 Martinez, and Deputy Grant.
