**Member Mandelman moved that this Resolution be AMENDED, AN AMENDMENT OF THE WHOLE BEARING SAME TITLE, on Page 1, Lines 13-15, to strike 'significantly alter the governance structure of the San Francisco Police Commission; and WHEREAS, Among the proposed changes are transferring exclusive authority to appoint and remove the Chief of Police to the Mayor'; Page 1, Lines 16-19, to replace 'allowing removal of commissioners by elected officials, and limiting the Commission's role in confirming mayoral appointments' with 'while having Commission serve as an appellate body that hears appeals, and grant the commission hiring and firing authority over the Director of the Department of Police Accountability'; Page 1 Line 20, to replace 'Concentrating' with 'Shifting'; Page 1, Lines 21-22, to replace 'shared governance' with 'pubic oversight'; Page 3, Lines 23-24, to replace 'proposed restructuring' with 'changes to disciplinary authority and process'; Page 4, Lines 5-6, to strike 'over policy, leadership oversight and'; Page 4, Line 6, insert 'oversight and'; Page 4, Line 8 to replace 'curtail the' with 'transfer the'; Page 4, Line 8-9 to strike 'autonomy or transfer its'; and make clarifying and conforming changes.
