18 organization involved in urban forestry or other environmentally-related issues, for a two-year  
19 term ending April 5, 2009.

20 Milton Marks, succeeding himself, term expired, seat 6, must be an at-large member,  
21 for a two year-term ending April 5, 2009.

22 Jocelyn Cohen, succeeding herself, term expired, seat 7, must be an at-large member,  
23 for a two-year term ending April 5, 2009.

24 Lena Miller, succeeding herself, term expired, seat 8, must be an at-large member, for  
25 a two-year term ending April 5, 2009.
