1	[Full Day Alternatives to Summer School.]

3	Resolution urging the Mayor to fund \$388,300 for full-day alternatives to summer
4	school for 2003 from the Children's Fund submitted to the Board of Supervisors for its
5	consideration on June 1, 2003.
6	
7	WHEREAS, Due to proposed state cuts to public education funding in California, the
8	San Francisco Unified School District (SFUSD) announced the scaling back of summer
9	school, including elimination of most summer school slots serving school children ages 6-13;
10	and
11	WHEREAS, In addition, due to these proposed cuts and planned facilities upgrades,
12	the SFUSD also announced that many school sites formerly used by non-profit organizations
13	to serve children in full or part-day summer programs would not be available this summer; and
14	WHEREAS, In response to an emerging crisis that could leave many children without
15	recreational and educational activities this summer, leave their parents struggling to develop
16	child care alternatives and threaten to undermine delinquency prevention efforts of the
17	SFUSD and the City, the City's Department of Children, Youth and Their Families (DCYF), in
18	partnership with the Recreation and Park Department, initiated a community planning process
19	to develop full-day alternatives to summer school and negotiate access to an increased
20	number of school sites this summer for community-based organizations (CBOs) and Beacon
21	Centers serving children; and
22	WHEREAS, In this process, DCYF surveyed the capacity of existing DCYF-funded and
23	other CBOs and Beacon Centers to serve an expanded number of children, if access to
24	schools could be negotiated; and

1	WHERAS, In response, many CBOs and Beacon Centers have initiated planning and
2	hiring efforts to accommodate an increased number of children in their summer programs; and
3	WHEREAS, The SFUSD responded favorably to DCYF proposals by reducing
4	proposed fees to DCYF; and
5	WHEREAS, Members of the Board of Supervisors have been working cooperatively
6	with the Mayor's Budget Office and DCYF staff to develop a budget to provide such increased
7	capacity to full-day alternatives to summer school; and
8	WHEREAS, DCYF staff have developed a proposed program to serve an additional
9	2,270 children this summer with a budget of \$388,300, including access to 9 school sites and
10	involving 15 CBOs and Beacon Centers, including the Boys and Girls Club and the YMCA;
11	now, therefore, be it
12	RESOLVED, That the Board of Supervisors commends DCYF, Recreation and Park
13	Department, participating CBOs and the SFUSD for their cooperative planning efforts to
14	resolve the pending crisis and urges the Mayor to fund \$388,300 for full-day alternatives to
15	summer school for 2003 from the Children's Fund submitted to the Board of Supervisors for
16	its consideration on June 1, 2003.
