3 **Ordinance authorizing settlement of the lawsuit filed by Patrick Marks against the City**
4 **and County of San Francisco for \$55,000; the lawsuit was filed on May 19, 2022, in San**
5 **Francisco Superior Court, Case No. CGC-22-599713; entitled Patrick Marks v. City and**
6 **County of San Francisco; the lawsuit involves alleged personal injury on a City**
7 **sidewalk.**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Patrick Marks v. City and County of
11 San Francisco, et al, San Francisco Superior Court, Case No. CGC-22-599713 by the
12 payment of \$55,000. The lawsuit involves alleged personal injury on a City sidewalk.

13 Section 2. The above-named action was filed in San Francisco Superior Court on May
14 19, 2022, and the following parties were named in the lawsuit: Plaintiff Patrick Marks and
15 Defendant City and County of San Francisco.
