WHEREAS, Currently in the San Francisco Unified School District, students receive little, if no, education regarding legal rights for minors; and

WHEREAS, The Public Health Committee of the Youth Commission has been working for the last term to ensure complete confidentiality at the Wellness Centers; and,

WHEREAS, The Family Emancipation Rights and Protection Act (FERPA) has prohibited Wellness Center Coordinators from providing completely confidential services because they are employed by the San Francisco Unified School District; and,

WHEREAS, For the last two months, the Public Health Committee has distributed over 65 surveys to students at high schools with Wellness Centers; and,

WHEREAS, Amongst the 57 students asked about whether or not they wished to receive more information regarding their health rights, 80.6% answered in the affirmative; and,

WHEREAS, Students and minors often times do not know about their rights regarding their health, public safety and civil rights and therefore cannot take personal responsibility for any of them; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco hereby urge the Board of Education to integrate a 'Know Your Rights Day' intended to educate youth about their rights, into the San Francisco Unified School District's (SFUSD) schedule; and, be it

FURTHER RESOLVED, That this 'Know Your Rights Day' is coordinated with efforts by students and teachers alike; and, be it

FURTHER RESOLVED, That this 'Know Your Rights Day' incorporate all aspects of Minor Rights, from accessing Health Care to interacting with Law Enforcement Agents; and be it
