18 School Lesson Study Math Pilot, its expansion, and use of funds from the Student Success
19 Fund, in order to successfully prepare all students to excel in math and be ready for 8th Grade
20 Algebra, and ensure that the investments of the City in this program continue to support this
21 and other successful innovations; and be it

22 **FURTHER MOVED**, That the Board of Supervisors convene to sit as a Committee of
23 the Whole, on October 29, 2024, at 4:00 p.m., to hold a public hearing on the results of the
24 first two years of the City funded Whole School Lesson Study Math Pilot, and understand how
25 the Student Success Fund dollars are being spent in accordance with the law creating the

1 fund, requesting representatives of the pilot school sites, SFUSD Superintendent, members of
2 the Board of Education, and the leadership of Department of Children, Youth and Their Family
3 to be present.
