13 WHEREAS, The Stern Grove Festival is an admission-free, performing-arts series
14 presented by the Stern Grove Association at Sigmund Stern Grove; and,

15 WHEREAS, The Stern Grove Festival Association has been planning and organizing
16 the Stern Grove Festival since 1938; and,

17 WHEREAS, Over the past year, the Stern Grove Association has successfully
18 managed a \$15 million renovation project to install a new stage and retractable canopy, to
19 terrace the meadow, build new pathways, restrooms and patron amenities and design new
20 landscaping to beautify the concert meadow; and,

21 WHEREAS, This year, the Stern Grove Festival will be launching their 68th season
22 serving thousands of Bay Area residents over its 10 concert series; now, therefore, be it

23 **RESOLVED**, That the Board of Supervisors hereby commends the Stern Grove
24 Festival Association for its work planning and organizing the 68th Annual Stern Grove Festival
25 in San Francisco; and, be it

1 FURTHER RESOLVED, That the Board of Supervisors congratulates the Stern Grove
2 Association on the rededication of new facilities at Sigmund Stern Grove and the Rhoda
3 Goldman Concert Meadow.
