9 Section 1. Pursuant to Charter section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Chris Escher v. City and County of
11 San Francisco, et al., San Francisco Superior Court, Case No. CGC-12-523236 by the
12 payment of \$40,000.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 August 14, 2012, and the following parties were named in the lawsuit: plaintiff Chris Escher;
15 defendants City and County of San Francisco and Comcast of California III, Inc.




