8 MOVED, That the Board of Supervisors of the City and County of San Francisco does
9 hereby appoint the hereinafter designated persons to serve as members of the Cannabis
10 State Legalization Task Force, pursuant to the provisions of Administrative Code, Article II,
11 Sections 5.2-1 through 5.2-7, for the terms specified:

12 Jesse Stout, seat 9, new appointment, must be an individual with at least two years of
13 experience working in the cannabis industry, for a one-year term ending August 31, 2016.

14 Erich Pearson, seat 10, new appointment, must be an owner or operator of a medical
15 cannabis dispensary, for a one-year term ending August 31, 2016.

16 Michelle Aldrich, seat 11, new appointment, must be an individual who uses cannabis
17 for medicinal purposes and has at least two years of cannabis legalization advocacy
18 experience, for a one-year term ending August 31, 2016.

19 Sara Payan, seat 12, new appointment, must be an individual who uses cannabis and
20 has at least two years of cannabis legalization advocacy experience, for a one-year term
21 ending August 31, 2016.

22 Jon Ballesteros, seat 15, new appointment, must be an individual with experience
23 working to advance the tourism or hospitality industry in San Francisco, for a one-year term
24 ending August 31, 2016.

1 Barbara Fugate, seat 16, new appointment, must be an individual who represents a
2 neighborhood association, for a one-year term ending August 31, 2016.

3 Tom McElroy, seat 17, new appointment, must be an individual who represents a
4 neighborhood association, for a one-year term ending August 31, 2016.

5 Laura Thomas, seat 18, new appointment, must be an individual with experience in
6 public health advocacy focusing on drug policy, for a one-year term ending August 31, 2016.

7 Terrance Alan, seat 19, new appointment, must be an individual working in the
8 entertainment or nightlife industry, for a one-year term ending August 31, 2016.

9 Sarah Shrader, seat 21, new appointment, must be a public policy expert working for
10 an organization focused on the formulation of good public policy, for a one-year term ending
11 August 31, 2016.

12 Daisy Ozim, seat 22, new appointment, must be an individual between the ages of 21
13 and 30 at the time of appointment, for a one-year term ending August 31, 2016.
