3 **Ordinance authorizing settlement of the lawsuit filed by Cheryl Jarne against the City**  
4 **and County of San Francisco for \$40,000; the lawsuit was filed on March 2, 2018, in San**  
5 **Francisco Superior Court, Case No. CGC-18-564726; entitled Cheryl Jarne v. City and**  
6 **County of San Francisco, et al.; the lawsuit involves an alleged personal injury on a**  
7 **City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Cheryl Jarne v. City and County of  
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-18-564726 by the  
13 payment of \$40,000. The lawsuit involves an alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 March 2, 2018, and the following parties were named in the lawsuit: Cheryl Jarne, Plaintiff.  
16 City and County of San Francisco; Philip Bellber; Rosemary MacGuinness; Cha Cha Cha  
17 Restaurant; Resho Corporation, Defendants.


