Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Campaign and Governmental Conduct Code is hereby amended by adding new Section 3.500, to read as follows:

Sec. 3.405. Prohibition on Use of Public Funds for printed Greeting Cards

- (a) Definitions. The term "greeting card" means any printed card, letter, or other item, whether in written, electronic, video, audio, or other form, that celebrates or recognizes a holiday.
- (b) Prohibition. No public funds may be used to design, produce, create, mail, send, or deliver any printed greeting card. The Controller of the City and County of San Francisco shall, in the Controller's sole discretion, determine whether a payment is prohibited under this section.

The Controller's decision regarding whether a payment is prohibited under this section is final.
