

Pursuant to Section 16.114 of the San Francisco Charter and California Government Code Sections 25170 and 37104, the San Francisco Board of Supervisors hereby commands you to appear at 10:00 a.m. on February 4, 2022 at the following location, unless your appearance is excused as indicated in paragraph 2 below, or you make an agreement with the person named in paragraph 3 below.

2. You are not required to appear in person if you produce (a) the records described in paragraph 4 below and (b) a completed declaration of custodian of records in compliance with Evidence Code sections 1560, 1561, 1562, and 1271.
3. If you have any questions about the time or date you are to appear, or if you want to be certain that your presence is required, contact Angela Calvillo, Clerk of the Board of Supervisors, at 415-554-5184.
4. You shall produce the following documents at the time and place specified above:
 - a) All documentation identifying all accounts and sub-accounts maintained by the San Francisco Parks Alliance that have received funds intended for, or have been used to pay or cover expenses for, the San Francisco Recreation and Parks Department since July 1, 2016; and
 - b) All documentation identifying the expenditures and other transactions made using the accounts identified in request 4(a) since July 1, 2016; and
 - c) All documentation identifying the source(s) of funding held in the accounts identified in request 4(a).

Failure to comply with the commands of this subpoena may subject you to enforcement proceedings before the Superior Court of the State of California.



DECLARATION IN SUPPORT OF CIVIL SUBPOENA DUCES TECUM

1. I, Angela Calvillo, am the Clerk of the San Francisco Board of Supervisors, which is issuing this subpoena.
2. Upon information and belief, the San Francisco Parks Alliance has possession or control of the documents listed in paragraph 4 of the Civil Subpoena Duces Tecum, and shall produce them at the time and place specified in the Civil Subpoena Duces Tecum.
3. Good cause exists for the production of the documents because the Board of Supervisors has the authority to inquire into the conduct of any department of the City and County of San Francisco and to inspect any documents relating to the affairs of the county.

The documents described in paragraph 4 of the Civil Subpoena Duces Tecum are material to the Board's inquiry because they concern the conduct of the San Francisco Recreation and Parks Department, including but not limited to conduct related to contracting, financing of City projects, and acceptance of gifts.
