9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Patricia Gambino v. City and County  
12 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-17-560484 by the  
13 payment of \$50,000. The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 July 31, 2017, and the following parties were named in the lawsuit: plaintiff: Patricia  
16 Gambino; defendants: City and County of San Francisco and Temple Baptist Church of San




