

1 [State/Airport Maintenance Agreement]

3 **Resolution approving the final Maintenance Cooperative Agreement as it relates to the**  
4 **SFIA Inbound/Outbound Ramps Project which is by and between the City and County**  
5 **of San Francisco, acting through its Airport Commission, and the State of California.**

7 WHEREAS, The Inbound/Outbound Ramps Project is part of the San Francisco  
8 International Airport's Master Plan; and

9 WHEREAS, The State of California ("State") and the Airport, acting through its Airport  
10 Commission ("Airport"), entered into a series of agreements defining the terms and conditions  
11 of constructing the Ramps Project within State right of way; and

12 WHEREAS, An approved Maintenance Agreement was one condition for obtaining a  
13 State Encroachment Permit to construct the Ramps Project within State right of way; and

14 WHEREAS, The Airport Commission approved an interim Maintenance Agreement  
15 prior to the Ramps Project construction proceeding; and

16 WHEREAS, The State requires a final Maintenance Agreement prior to accepting the  
17 Ramps Project improvements for maintenance purposes; and

18 WHEREAS, The State and the Airport desire to enter into the final Maintenance  
19 Agreement and to substitute the final Maintenance Agreement for the interim Maintenance  
20 Agreement previously entered into by the parties; and

21 WHEREAS, The final Maintenance Agreement allocates maintenance responsibilities  
22 to the Airport for improvements outside of the State right of way and allocates maintenance  
23 responsibilities to the State for improvements within the State right of way, except otherwise  
24 provided in the Maintenance Agreement; and

1           WHEREAS, The Maintenance Agreement sets forth Airport responsibilities for  
2 maintaining customized Airport signs and sign structures, a variable message sign system,  
3 landscaping and drainage within State right of way; and

4           WHEREAS, The Maintenance Agreement allocates responsibilities to the Airport to  
5 fund the State's cost to maintain lighting on two customized Airport sign structures and to  
6 fund fifty percent of the State's cost to maintain traffic control signals and lighting at the San  
7 Bruno Avenue on and off ramps; and

8           WHEREAS, The Maintenance Agreement allocates responsibility to the Airport to fund  
9 up to \$60,000 for development of computerized data collection software necessary for  
10 monitoring the level of service (LOS) along the portion of the southbound collector/distributor  
11 (C/D) road between the San Bruno Avenue on-ramp and the Route 101 off-ramp; and

12           WHEREAS, The Maintenance Agreement commits the Airport to implement  
13 operational measures and project construction to improve the traffic operation on the C/D  
14 road, if and when the LOS exceeds LOS D, such that traffic density below LOS D or better is  
15 achieved; now, therefore, be it

16           RESOLVED, Pursuant to San Francisco Charter Section No. 9.118, that the Board of  
17 Supervisors hereby approves the Maintenance Agreement, a copy of which is on file with the  
18 Clerk of the Board of Supervisors, in File No. 010483, which is hereby declared  
19 to be a part of this resolution as if set forth fully herein.




