

1 [Grant Agreement - HomeBridge, Inc. - Contract Mode In-Home Supportive Services - Not to
2 Exceed \$158,400,000]

3 **Resolution approving an Agreement between the City, acting by and through the**
4 **Department of Disability and Aging Services, and Homebridge, Inc. for the provision of**
5 **Contract Mode In-Home Supportive Services, for a term of four years from July 1, 2025,**
6 **through June 30, 2029, for a total not to exceed amount of \$158,400,000; and to**
7 **authorize the Department of Disability and Aging Services to enter into amendments or**
8 **modifications to the First Amendment that do not materially increase the obligations or**
9 **liabilities to the City and are necessary to effectuate the purposes of this Resolution.**

11 WHEREAS, The City and County of San Francisco, by and through its Department of
12 Disability and Aging Services, wishes to provide grant funding for services provided to the
13 community for contract mode in-home supportive services to eligible older adults and adults
14 with disabilities in order to enable these individuals to remain safely in their homes; and

15 WHEREAS, On December 17, 2024, the Department of Disability and Aging Services,
16 in coordination with the Human Services Agency, issued a Request for Proposals #1151 for
17 In-Home Supportive Services (IHSS) Contract Mode grant-funded services; and

18 WHEREAS, Homebridge, Inc. submitted a proposal and was the only proposer; and

19 WHEREAS, The Department of Disability and Aging Services awarded the Agreement
20 to Homebridge, Inc.; and

21 WHEREAS, On March 5, 2025, the Department of Disability and Aging Services
22 Commission approved the proposed IHSS contract mode services grant with Homebridge,
23 Inc. (the "Grant Agreement") in a total amount not to exceed \$158,400,000 for the period from
24 July 1, 2025, through June 30, 2029; and

1 WHEREAS, The City and County of San Francisco, by and through its Department of
2 Disability and Aging Services, now wishes to enter into the Grant Agreement with
3 Homebridge, Inc.; and

4 WHEREAS, Charter, Section 9.118(b) requires Board of Supervisors' approval by
5 Resolution of any contract which, when entered into, extends over 10 years, and of any
6 contract which, when entered into, costs the City \$10,000,000 or more; and

7 WHEREAS, The proposed Grant Agreement contained in File No. 250224, is
8 substantially in final form, with all material terms and conditions included, and only remains to
9 be executed by the parties upon approval of this Resolution; now, therefore, be it

10 RESOLVED, That the Board of Supervisors hereby approves the Grant Agreement in
11 substantially the form contained in File No. 250224; and, be it

12 FURTHER RESOLVED, That the Board of Supervisors authorizes the Department of
13 Disability and Aging Services to make any modifications to the Grant Agreement, prior to its
14 final execution by all parties, that the Department of Disability and Aging Services determines,
15 in consultation with the City Attorney, are consistent with this Resolution, in the best interest of
16 the City, do not materially increase the obligations or liabilities of the City, are necessary or
17 advisable to effectuate the purposes of the Grant Agreement, and are in compliance with all
18 applicable laws, including City's Charter; and, be it

19 FURTHER RESOLVED, That within 30 days of the Grant Agreement being fully
20 executed by all parties, the Department of Disability and Aging Services shall submit to the
21 Clerk of the Board of Supervisors a completely executed copy for inclusion in File No. 250224;
22 this requirement and obligation resides with the Department, and is for purposes of having a
23 complete file only, and in no manner affects the validity of the approved Grant Agreement.
