6 **was filed on December 10, 2007 in Sacramento Superior Court, Case No. 34-2007-**  
7 **00882854; entitled Metromedia Fiber Network Services, Inc., a Delaware corporation, v.**  
8 **City and County of San Francisco, et al.; the complaint was amended on August 20,**  
9 **2009 to correct the plaintiff's name to AboveNet Communications, Inc.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. The City Attorney is hereby authorized to settle the action entitled  
12 "AboveNet Communications, Inc. v. City and County of San Francisco, et al.," Sacramento  
13 Superior Court, Court No. 34-2007-00882854 by the payment of \$183,479.00.

14 Section 2. The above-named action was filed in Sacramento Superior Court on  
15 December 10, 2007, and the following parties were named in the lawsuit: Plaintiff Metromedia  
16 Fiber Network Services, Inc.; Defendants California State Board of Equalization, County of  
17 Alameda, County of Contra Costa, County of Los Angeles, County of Marin,






